NCC to construct Gardermoen wastewater treatment plant

NCC has been awarded the contract to construct the new Gardermoen wastewater treatment plant for Ullensaker Municipality In addition to the construction of the new plant, the assignment includes connecting the new and existing treatment plants. The project is being carried out in the form of a turnkey contract and the contract value is NOK 240 million.

The project involves groundwork, earth removal and concreting works, in addition to restoring grass surfaces, meadows and forest floor.

"This is an extensive project with several unique operations that are well suited to our organization. We have broad experience of large-scale groundwork and concreting projects, as well as large and small-scale water and sanitation projects. We look forward to the construction process and to handing over a modern wastewater treatment plant that both we and Ullensaker Municipality can be proud of," says Renate Berget, District Manager at NCC Infrastructure.

NCC submitted the most competitive tender and won on quality. The price offered by NCC was the highest, but the quality criteria, ability to implement the project and competence of the key individuals included in the tender were rated the highest. Overall, NCC's tender was thus determined to be the best.

Paperless project implementation

The project will be implemented and documented in a paperless process, with all drawings handled in BIM models. This significantly streamlines planning, implementation and future operation.

The new treatment plant will be considerably larger that its existing counterpart and will meet more stringent standards for a reduction in the total amount of phosphorus in the treatment process. The treatment plant will feature in-situ cast concrete tanks extending ten meters below ground level. In addition, the administration building will be renovated, and a new pre-treatment plant and new inlet pumping station will be constructed. The treatment plant will be constructed in a building with a base measuring 4,800 square meters with two floors as well as a lower level and basement.

The contract will be registered among orders in the second quarter of 2021 in the NCC Infrastructure business area.

Construction will commence in August 2021 and conclude in June 2025.
